**Community members concerns and statements** - No comments from the community

<u>County Rep</u>: Jerry Madson – Advised the board the Allan Ruffles the County Treasurer works with a bank regarding investments that gives a higher percent of interest than others. Supervisor Wing said that she was presenting NYCLASS to the board later in the meeting regarding this. Mr. Madsen asked how the new recycle container was working out at the transfer station and Councilman Galley said that it is definitely getting filled up and we have a lot of residents that recycle so the second container was definitely needed.

## Fuel Bid Opening

The town received sealed bids from the following fuel providers; Mirabito Energy Products, Buell Fuels and Broedel Fuel Group. After reviewing all bids submitted it was found that Broedel was the low bidder.

#### Assessor - Sheri Falcone

Re Evaluation with ENPM Inc. - Jim Emminger to be present- Grievance day this year will be May 30th 4-8pm.

ENPM has been in the appraisal business for 37 years and have served Delaware County, Southern Tier, West of Syracuse, Seneca Falls, Oneida, Walton and smaller communities. They want to assure residents there is nothing to worry about. They will be holding a public presentation explaining the Valuation project in the Towns Burlington and Edmeston and Pittsfield. They suggested having a joint public meeting with the neighboring towns and having at least 2 of them so there will be more than one day residents can attend. He will check dates and advise which days will be best, they will not be held until June. They will publicize when and where the public meetings will be held. There will be a power point presentation as well as a website with information, and a dedicated phone number to call to ask questions. The process will be very transparent, the more the public knows the better. The purpose of the revaluation is assure that people are only paying their fair share so it will even it out; people paying too much will see their taxes go down, people paying too little will see their taxes go up. The valuation is based on sales, this has been done two ways; looking at the sales for the town for example if there are 75 sales in 6 years they can keep it in town, if the sales in the town are low they may look at sales in neighboring communities, for example Morris and Edmeston.

Board of assessment review- need members to review any Grievances, we have 2 currently, 3 open positions - Members will be required to take small training class prior to Grievance Day which should be available online.

#### **Ambulance**

CON was set to expire 3/31, Ambulance service and Supervisor worked together to file proper paperwork and CON was renewed.

Current contract ends the end of June, verbal proposal was same as current \$7500 for 6 months.

#### Fire department- Chief Tim Lidell .

Board was invited to banquet to be held April 15<sup>th</sup>. Chief Lidell submitted a report for the fire department to the board. He has not provided a list of members that would qualify and be interested in the tax reduction for emergency personnell.

Annual audit and resolution was filed March 24th

JCAP grant was obtained in the amount of \$13,404.83 to be used to ensure security of information and proper storage of files which includes construction to expand office space/judges chambers for judicial/attorney discussions. Desk which will ensure security of computer, locking cabinets and files cabinets. This work has to be completed and documents submitted within the next 6 months.

Prior Judge Bill Curto- Closing out bank account is pending Hon Donna Yerdon is assisting. \$1361.02 remains in Judge Curto's account,

He would also like to seal Musk Road and Jennison Road this year. His goal is to try and budget to do seal 5 miles a year to stay in rotation. The cost to pave 1 mile is \$ 140,000.00

# Financial-

Other investment opportunities being looked into, NYCLASS and Bank of Cooperstown are offering >4% interest on money markets currently. Double of what our MM give currently, CD's are another option but this locks funds up MM would maintain liquidity.

Supervisor working with Jamie A. Reynolds SVP Regional Executive/Government Banking and local NBT brank to increase return on investments. CD rates are 3-4% through NBT but funds would not be liquid and would have to be laddered to ensure funds were available when needed

NYCLASS has had interest rates >4.5% recently they do fluctuate, returns are deposited daily and do compound. Funds are liquid and can be transferred at any time to our NBT accounts within 24 hours.
