Regarding raising the rates for subdivisions- Curtis subdivision that took place, surveyor expressed that because the new fee was not filed with the department of state it was not valid, paid \$25 per parcel- 3 parcels. Addendum to the local subdivision law needs to be written and filed with the secretary of state. - Contacted our attorney, the paperwork is set up as an ordinance not a law, so this does not have to be sent into the secretary of state. Supervisor is working with the attorney to ensure the proper procedure takes place to change the fee.

2021 elections - On the ballot- 2 councilman positions, both are 4-year terms, clerk, supervisor, and highway superintendent. Petition signatures are currently open and need to be turned in March 22-25th.

Financials

-Fund balance money market accounts have been set up. 20% highway, 40% general

-Fire Department was paid their taxes collected on 2/20/2021

-Tax collection- \$219058.76 deposited in highway checking 2/27/2021, all warrants for 2021 for town have been fulfilled

- Payment in the amount of \$13586.42 was received from the department of homeland security. From FEMA payment 2019

New Business:

- Covid Rescue Package- local funding-

166 million will go to towns/cities/villages in NY 19- based on population % of NYS.

19.48 million in NYS 1300 in Pittsfield = .0000666324%- estimated \$10-12,000 in relief

Money to be used to cover cost of lost revenue, spending related to covid, to cover negative impacts of Covid, projects that would like to take place in response to covid 19- How has covid affected Pittsfield financially in 2020.

- Increased transfer station cost
- Delay of web page - took to pay transfer station bills.
- Reduced chips funding
- Reduced ambulance calls resulting in reduced income.
- Effects on local businesses?

- Possible Grant funding- "clean energy communities" through NY energy research and development authority-
